What the Position Entails

Responsibilities:

- Evaluate, assign and monitor property performance. Work with team to prioritize issues and develop action plans to address challenges.
- Continuously seek opportunities to optimize property performance and increase cash flow.
- Work with property management company to prepare annual operating budgets.
- Lead monthly review of each asset's performance and report to Director of Asset Management.
- Conduct quarterly visits to each property in portfolio.
- Manage disposition processes and buyer due diligence requests.
- Review appraisals and provide thorough compelling analysis to increase appraised value of assets.
- Analyze rent roll, lease expiration schedule, vacancy rates, unit availability and marketing/leasing efforts to maximize occupancy and collection rates.
